Nepal, India agree to expand cooperation in agriculture sector

Nepal and India have agreed to formulate and implement a biennial action plan within the next three months to translate bilateral agreements on agricultural cooperation into tangible outcomes, Nepal's Ministry of Agriculture and Livestock Development. The decision was taken during the ninth meeting of the Nepal-India Joint Agriculture Working Group, held in Kathmandu on Sunday and Monday. The two sides also agreed to strengthen cooperation between agricultural universities and research institutions in both countries, including the Indian Council of Agricultural Research (ICAR) and the Nepal Agricultural Research Council (NARC), through separate, time-bound action plans, the ministry said in a statement.

Cameroon-Morocco Agreement Targets New Investment Flows

Cameroon's Investment Promotion Agency (IPA) signed an investment promotion agreement with Morocco to expand cross-border projects and strengthen economic cooperation. The deal, formalised through a Memorandum of Understanding between IPA and the Moroccan Agency for Investment and Export Development, AMDIE, sets out a framework for closer collaboration, as Cameroon intensifies efforts to draw regional investors into its economy. The MoU was signed at AMDIE's headquarters in Rabat by IPA's interim Director General, Boma Donatus, and AMDIE Director General, Ali Seddiki. The agreement focuses on cooperation in investment promotion, information sharing and the identification of joint opportunities between the two countries. IPA said the deal positions both agencies to work more closely to attract and facilitate investments, particularly as Cameroon expands its outreach to international investors through a targeted economic mission in Morocco.

India delivers ambulances to Afghanistan amid growing health cooperation

India has delivered a batch of ambulances to Afghanistan as health cooperation between the two countries continues to strengthen. In October, during a visit by Afghanistan's Foreign Minister Amir Khan Muttaqi to India, New Delhi announced its plan to donate 20 ambulances to Afghanistan as a gesture of goodwill. The delivery forms part of the expanding partnership between the two countries in the healthcare sector. Recently, Afghanistan's Minister of Public Health, Noor Jalal Jalali, visited New Delhi and noted that Kabul is exploring alternative avenues for procuring medicines, reducing reliance on Pakistan.

Minister of Agriculture in River Nile Discusses Cooperation with Red Crescent and FAO

The meeting discussed the progress of work in the vegetable seeds distribution and extension project; FAO grant being implemented by the Red Crescent Society's River Nile Branch in cooperation with the Ministry of Agriculture, Irrigation, and Forests through its relevant administrations (Horticulture, Extension, Seeds) with support from FAO. The project targets small-scale farmers and household agriculture, aiming to enhance food security and improve farmers' livelihoods in the state. The parties emphasized the importance of joint cooperation between the ministry and international organizations to strengthen the agricultural sector and achieve sustainable development. He indicated that this project will contribute to providing improved seeds to farmers and offering the necessary technical extension to increase productivity and enhance the quality of agricultural products.

South-South Cooperation gains ground through UN-supported technical exchanges

The United Nations in India is supporting a set of South-South Cooperation projects under the UN India SDG Country Fund focusing on technical cooperation and capacity building across health, education, statistics and food systems. The projects are implemented by UN agencies in partnership with Indian government institutions and counterpart authorities in participating countries. In healthcare, United Nations Development Programme is supporting Laos PDR and Zambia to strengthen equitable access to health services by adapting Indian digital health platforms. The project focuses on developing standard operating procedures and customised digital solutions inspired by India's eVIN, CoWIN and U WIN platforms to support real time tracking of non-communicable disease medicines and service delivery. UNDP teams engaged with government counterparts in Laos PDR to assess system requirements, followed by a visit by Lao officials to India to observe digital health systems in use. Exposure and training engagements for Zambian officials are planned as part of the project.

Algeria and Belarus Sign Multiple Cooperation Agreements

The Algerian President, Abdelmadjid Tebboune, on Wednesday co-chaired with his Belarusian counterpart, Alexander Lukashenko, the signing ceremony of several agreements and memorandums of understanding in various fields of cooperation between the two countries. The signing ceremony took place at the Presidency of the Republic, following talks between both Presidents, who is on an official visit to Algeria. In this context, the governments of the two countries concluded an agreement on military and technical cooperation, signed by Army General, Minister Delegate to the Minister of National Defense and Chief of Staff of the People's National Army (ANP), Saïd Chanegriha, and Belarusian Minister of State for the Military Industry, Dmitry Pantus.

QFFD Provides Over \$667 Million in Aid Throughout 2025

Qatar Fund for Development (QFFD) provided over \$667 million in aid through 2025 for more than 45 countries, culminating in a year abounding with forged partnerships and achieving a concrete breakthrough in lending impetus to the agenda of development and humanitarian work on the global stage. The 2025 aid had been distributed to the healthcare sector with nearly \$62.1 million, over \$74.1 million to education, nearly \$314.9 million to economic development, as well as over \$141.1 million to humanitarian aid, among other areas, QFFD clarified in its annual bulletin.

TV BRICS unites over 100 media organisations worldwide to strengthen cooperation across Global South

TV BRICS International Media Network ensured three times more media publications across different countries on the activities of the BRICS group and state-level humanitarian and economic cooperation compared with the previous year. Today, 32 countries regularly participate in shaping the consolidated BRICS agenda, seven of which joined cooperation with TV BRICS during 2025: Bolivia, Indonesia, Malaysia, Mexico, Thailand, Uruguay, and Sweden. Over the year, the media network connected an additional 24 media outlets from 17 countries worldwide to multilateral information exchange. Overall, 110 regional, national, and global media organisations officially cooperate with TV BRICS. New partners include Malaysian National News Agency BERNAMA, Indonesia's largest television broadcaster TVRI, India's leading public broadcaster Prasar Bharati, Thailand's public television service Thai PBS, and Brazil's news portal Brasil de Fato.

Japan to Provide \$7 Million Grant to Boost Healthcare Infrastructure in Kazakhstan

Japan will provide more than 1.087 billion yen (approximately US\$7 million) in grant assistance to support the development of healthcare infrastructure in Kazakhstan's Abai Region, strengthening bilateral cooperation in medicine and public health. Kazakh Minister of Healthcare Akmarał Alnazarova and Japan's Ambassador to Kazakhstan Iijima Yasumasa signed the document to implement an intergovernmental agreement on a Japanese grant. The funding will be directed toward upgrading medical infrastructure at the University Hospital of the Non-Commercial Joint-Stock Company Medical University of Semei. The grant will be used to procure high-tech medical equipment, significantly expanding the hospital's diagnostic and treatment capacity.

Togo's 65-year Partnership with the UN Lays Ground for a Sustainable Future

Togo reached a major milestone, moving from the category of low human development countries to medium human development, with a Human Development Index (HDI) of 0.571. This progress ranks Togo second in the West African Economic and Monetary Union (WAEMU) region and reflects collective efforts from Government, civil society and the UN in poverty reduction and socio-economic reforms in health, education and water—key contributors to achieving the Sustainable Development Goals. The UN's support has covered a wide range of areas, from migration governance to refugee protection and humanitarian aid in vulnerable regions. From health and social protection to jobs and youth empowerment, every initiative sought to build resilience for the Togolese people.



President Guelleh said the visit reflects the deep-rooted and historic ties between Djibouti and Egypt, which constitute a solid foundation for advancing the interests of both nations. He highlighted the significance of President Abdel Fattah Al-Sisi's historic visit to Djibouti, during which both sides stressed the importance of expanding bilateral cooperation across multiple sectors and increasing trade volumes to better reflect the strength of relations.
