# Accelerating Clean Cooking in Africa: Balancing Cost, Culture, and Innovation

Access to clean cooking technologies in Sub-Saharan Africa remains critically low, despite notable progress in recent years. As of 2020, approximately 923 million people across the continent still lacked access to clean cooking solutions. In many rural households, cooking is predominantly done using three-stone traditional stoves, where a pot is balanced over an open flame. Often used indoors, these stoves emit high levels of smoke and particulate matter, severely compromising indoor air quality. Women, who are typically responsible for cooking, face the highest exposure to this pollution, increasing their risk of respiratory illnesses, eye problems, and other health complications. Additionally, the reliance on firewood not only drives deforestation but also limits women's economic productivity, with many spending an average of three hours per week collecting firewood.

# World Health Depends on Global South Status: PM Modi

In a major development for public health and improving preparedness for future pandemics, India has joined other WHO member states in jointly adopting the global pandemic treaty at the World Health Assembly in Geneva. The summit's key objective was to conclude negotiations on the Global Pandemic Treaty, and the Prime Minister congratulated the World Health Organization (WHO) and all member states on the successful conclusion of negotiations by the Intergovernmental Negotiating Body (INB) on the Pandemic Treaty. The adoption was based on the approval of the Agreement by vote in Committee by Member State delegations.

It directly responds to the requests of the IsDB's Governors and is a key outcome of the Riyadh Declaration@50, adopted during the IsDB's Golden Jubilee in 2024.

Led by the Government of Rwanda, the side event brought together a powerful coalition of co-hosts, including Eritrea, Ethiopia, Namibia, South Sudan, Uganda, the United Republic of Tanzania and Zambia.

# The Africa Centres for Disease Control and Prevention (Africa CDC) and Unitaid Enter New Strategic Partnership

The Africa Centres for Disease Control and Prevention (Africa CDC) and Unitaid have formed a new strategic partnership to expand the production of essential health products in Africa and improve sustainable access to medicines, diagnostics, and medical oxygen across the continent. Signed on the margins of the 78th World Health Assembly, the Memorandum of Understanding focuses on scaling up regional manufacturing as a central pillar of Africa's health security and autonomy. These efforts will target key health priorities such as HIV, tuberculosis, malaria, hepatitis, cervical cancer, sexually transmitted infections, and other diseases and conditions – particularly those affecting women and children.

The 2nd Edition of the East African Digital Leaders Forum on Digital Public Infrastructure (DPI) is currently underway at the EAC headquarters in Arusha, Tanzania. The forum seeks to to review progress, facilitate joint action and foster cross-border digital infrastructure development in the region. The objective of the three-day meeting supported by the German Agency for International Cooperation (GIZ) is to assess the implementation of DPI initiatives across EAC Partner States since the August 2024 workshop, focusing on building trusted DPI with Safeguards and facilitating cross-border collaboration by bringing together interoperable digital identity, e-payment and data exchange mechanisms across the region.

#### **Indonesia Prepares New Cybersecurity Law**

The Indonesian government is preparing a revision of the Cybersecurity and Resilience (RUU KKS) that will include penalties for platforms that fail to adequately protect their cybersecurity, according to the Deputy Head of the National Cyber and Encryption Agency (BSSN), Rachmad Wibowo. According to him, the government completed harmonization process at the end of April and plans to hold a focus group discussion (FGD) to ensure proper socialization of this legislation. The Cybersecurity and Resilience Bill is a priority within the government's National Medium-Term Development Plan (RPJMN) 2025-2029.


